**Who?** C3-4CANADA was established in March 2021 by a Canadian, former Senior United Nations professional, and current PhD Candidate, who, after researching the current situation of Canadian and global economics and governance in depth, understands that there is, beyond any doubt, the urgent need for taking action to ensure Canada remains strong and free. All who share this goal for Canada are welcome to participate.

**What?** C3-4CANADA is primarily a networking and information-sharing campaign to help collaborate and coordinate communications. This effort takes the shape of a not for profit and unfunded neutral information and knowledge hub and contacts network.

**Long Term Objective:** Canada, strong and free, upholding all conventional national and international codes of human rights and values, upholding all international human rights treaties, upholding the Constitution of Canada and all that is entailed and associated with these agreements, conventions, treaties et al, *formed by formally mandated, regular, transparent, participatory, regulated and democratic processes in functioning democratic governance.*

## **Short Term Objectives:**

1. ***Aligning the Contextual Narrative with Reality***
  - 1.1 Canadians aware of the factual, neutral and evidenced-based information associated with the *Great Reset of the Fourth Industrial Revolution*, which is largely, highly counter-intuitive of, and counter-productive to, the goals as listed as above, in the Long Term Objective.
  - 1.2 Canadians aware of the factual, neutral and evidenced-based information correcting the misinformation portrayed via a vi mainstream media, by entities within the private sector, civil society, governmental and intergovernmental sectors, in relation to Objective 1.1.
- 2 ***Standing Guard for Freedoms***
  - 2.1 Canadians knowledgeable and able to express their freedoms and rights as per the Canadian Constitution and as per over-arching international codes of human rights.
- 3 ***Standing Up for Rights***
  - 3.1 Canadians fully aware that they pay for the government and that government employees are civil servants and they work for the people of Canada who pay them.
  - 3.2 Canadians fully knowledgeable of the rights they as citizens and taxpayers hold.
- 4 ***Support for Public Sector Employees***
  - 4.1 A robust supportive network for the many professionals in the fields of health care, emergency response, education, law enforcement, governance and public sector generally, among others, who support the Long Term Objective and who do not wish to work towards the Great Reset of the Industrial Revolution.

**Why?** *The Great Reset of the Fourth Industrial Revolution*, led by the World Economic Forum, generally works against the Canadian Constitution and also against well-established international codes of human rights. All Canadians and all people globally too, truly do need to understand what this movement is about because it is impacting them and will continue to do so unless it is addressed. To underestimate the power of those engineering and funding the Fourth Industrial Revolution is a mistake.

The tasks inherent in planning, such as risk and impact assessments, the development of strategic frameworks, policies and legislation, project creation and implementation, financial tools and mechanisms, public policy and communications, all start from the same place. *This place is contextual understanding.* Many powerful entities from all sectors are obscuring and distorting reality often and greatly, thus making it impossible to address economic, social and ecological issues, and things will continue to degrade no matter what veneers of illusory well-being are applied by those same powers that be.

### ***Science Coopting and Evidence-shunning Official Narrative Distorts Reality***

**What’s going on?** Today, we see pieces of context reflective of reality, while at the same time, we see much of the context presented through the filters and censors directed and mediated by persons and groups of persons, who without doubt, are not neutral. We are “informed of the news” through screens facing us, filtering, distilling and funneling all facts into one common prescribed narrative. Now fully accustomed to watching the screens for so many hours of the day and for so many aspects of our lives including the uptake of most of all information, along with social interaction and entertainment, we watch small screens while on the go, and larger screens at home, passive receptors of messages which are too often reflecting smoky fun-house mirrors of reality.

The level of wealth, technology, human capital, intellectual capital, governance and access to economic control that the powers that be hold, is in no way reflected in the chaotic and illogical way COVID was, and is being managed, in many of the more developed countries, such as Canada. We ask why?

**Who can we Trust?** Few, if any, of the governmental and intergovernmental bodies, we were taught to trust, and to which a feudally-large portion of Canadian earnings go, have executed the mandates their callings dictate. The neon example is of course, the controllers, and their unquestioning and compliant assistants, of the medical and health realm. Our question to them is – Where was “First, Do no Harm” in this labyrinth of catastrophe, where the well-intended medical and health professionals who pledged first to their Hippocratic oath, above the contra-indicative commands of their superiors, were often positioned in submission, silenced and even stripped of their credentials.

**Suffering and Lost at Sea** - Clearly something is well rotten in the State -and in the world, and a vast number of people are suffering. Many who are not facing severe hardships due to COVID related issues, are still also suffering because they are noetically lost at sea, and emotionally strained, if not drained. The consistent discord between reality and what is portrayed formally, continually wears on both psyche and soul, and the map of the world as

we knew it, has been ripped from under our feet. For those with closed minds, their hearts and gut will know something big is off, and cause them misunderstood tangential forms of anxiety. This is a worse condition to be in than to know even the worst of news. And with such a scenario, where investigation and critical thinking are shunned, where straying from the prescribed narrative is censored and shamed, and where the majority of people remain under the tutelage, of the most highly invested, non-elected, non-technical and non-inclusive *Inclusive Planners* in history, the chances of attaining a collectively recognized understanding of the context, remains nil.

**Shaming Critical Thinking and Investigation** - Attempts at discovering the whole human context, (no matter how professionally and scholarly they are investigated and presented) consistently and without fail, are not picked up by the mainstream media. Publically available facts suggest that many of the powers that be today, have drifted far from conventional moral norms of human civilization. Many today, see that the real conspiracy leaders, who run real conspiracies in this real world, are dismissing, censoring, and attacking many of those who – normally without any form of gain and normally with losses and even risk - are simply trying to map and understand the context as it stands in reality, while often working to uphold citizen rights.

A number of people have a fairly good understanding of factors in play, yet these voices are whispers in the storm, while the vast majority of people look only to their known beacons – mainly government/intergovernmental bodies, *vis a vi* mainstream media, to guide them in troubled waters.

Without a well understood context, there is no way to undertake steps towards addressing an issue. Without a large number of people demanding the context be revealed, formally reported reality will continue to be skewed, incomplete and piecemeal, swaying with the winds of power, unquestioned - willows in wind. Many people are truly nascent, innocent of the underlying worlds driving things, but they well may feel that things are off, and those with inquiring minds and running moral compasses, will then be concerned, question and search for answers.
